2024 CODE OF CONDUCT POLICY



This Code of Conduct Policy aligns with the AIDKA Rule Book (Rules of Racing) (as amended) and provides a basis for appropriate behaviour associated with/at the Blanchetown Dirt Kart Club (BDKC) through membership, race participation, attendance and visitation.

The Blanchetown Dirt Kart Club promotes a safe, friendly but competitive, non-contact racing environment.

ALL PERSONS INCLUDING KART DRIVERS, PIT CREW/LICENSED OFFICIALS/LICENSED PERSONS/CASUAL LICENCE HOLDERS ARE DEEMED RESPONSIBLE TO ADHERE TO THIS POLICY.

ALL BLANCHETOWN DIRT KART CLUB MEMBERS ATTENDING OTHER CLUBS AS A COMPETITOR OR VISITOR ARE ALSO DEEMED TO BE RESPONSIBLE TO ADHERE TO THIS POLICY AS A REPRESENTATIVE OF THE BLANCHETOWN DIRT KART CLUB.

All persons shall;

- Be familiar with the AIDKA rules of racing.
- Participate in accordance and within the rules and in a sportsman like manner.
- Be responsible for their own conduct as well as the conduct of any persons that are associated with them eq: pit crew, kart owners and sponsors.
- Treat all participants in and associated with the sport, as you like to be treated. Bullying, intimidation, or harassment is also not acceptable behaviour under this code of conduct.
- Be mindful when using social media including personal sites such as:
 Facebook, Snapchat, X (formally Twitter), Instagram, etc and that the Blanchetown Dirt Kart Club, members, helpers or facilities are not to be commented on in a derogatory manner.
- Wear an arm/wrist band if in the pit area and appropriate clothing and enclosed footwear.
 The relevant driver/kart owner is responsible for all pit crew members at all times during the event.
- Not smoke or light fires in pit area.
- Not transport or consume Alcohol in the pit area.

- Respect the rights, dignity and worth of all participants regardless of their gender, ability, cultural background or religion.
- Work on or around karts in a safe manner and using safe methods at all times and in the designated pit area.
- Be ready to race with helmets and other safety equipment and pushers if needed when called.
- Leave the racetrack at a safe speed and terminate racing prior to leaving the track proper. All karts must stop and be exited before returning to the pit area. There will be no kart moving under its own power outside of the track.
- The Stewards decision will be and remain final. Protests may be undertaken in accordance with the AIDKA Rules.

If an Official's decision is not agreed upon and you feel aggrieved there are avenues that can be followed.

Please see your driver's rep for this information.

DO NOT abuse or otherwise any Officials, Volunteers, Helpers or fellow competitors or crew. This behaviour is not acceptable or tolerated at any time.

Harsh penalties can apply for people found to be guilty of this and any offence by both the AIDKA rules and also this the Blanchetown Dirt Kart Club Code of Conduct.

Any disputes or protests for a racing incident/dispute must be taken through a driver's representative to be dealt with in accordance with the AIDKA Rule book. In the event it is a club issue then approaching any of the Executive Members of the club in a calm, civilised manner is acceptable.
